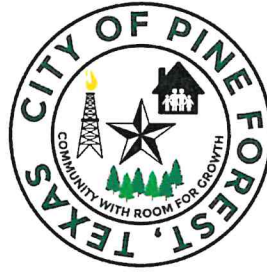
**Item 3:** Pledges to the United States Flag and Texas State Flag.




